### **Class Description:**

(Catalog) Credit 3 semester hours. An examination of the history, organization, and function of the various local and federal agencies that make up the criminal justice system. The survey is organized around the three major components of the criminal justice system: police, courts, and corrections.

### **Course Objectives:**

Intended as a basic introduction to the study of criminal justice, this course is an overview of (1) the processes of criminal justice and (2) a survey of the components of the criminal justice system (police, courts, prosecution, and corrections). Since this is the first criminal justice course taken by many students, the instructor will also deal with issues related to academic success: e.g., individual potential discovery and development, self-esteem, study skills, how to ace that exam, and what the future holds in relation to professional opportunities.

Upon successful completion of this course, the student will be able to converse logically about (1) the history of and the relationships between the criminal justice system components, (2) the basic function of each of the components, and (3) utilize legal terminology. The student will have a vision of the myriad job opportunities available in criminal and juvenile justice and in justice-related occupations, and he or she will have an understanding of how to study and understand a textbook, develop discipline, and thus become a superior student.

### **Lectures, Presentations, and Class Discussions:**

Text and handout materials must be read prior to class. The student must prepare to ask and respond to questions and participate in class discussions. The student must remember that informed and interested participation will greatly impact the student's final grade.
