***New Business:***

Proposals From:

- **Department of Atmospheric Science, Earth Science, and Physics:**  
**Change in Degree Plan:** B.S. in Atmospheric Science. Changes to comply with updated requirements from the American Meteorological Society.  
**Catalog Change:** Undergraduate Catalog (2010-11), page 91-92, 161-162.  
**Course Changes:** ATMS 1001, 1002, 1003, 2005, 3005-3006.  
**Course Closure/Removal:** ATMS 1010, 4001-4002.  
**Course Additions:** ATMS 1006, 2000, 4003, 4004.

***Accepted.*** The ASCC recommended the following changes to the forms:

- EXPLANATORY MEMO – Clarify the wording such as “components” (paragraph 1) and “elements” (paragraph 2) to be more descriptive. Change “Changes performed above” to “Proposed changes”. In #2b, 39 hours should be 40 hours and in #2c, ATMS 4002 should be 4004.
- CATALOG CHANGE form – #1 on the form was left blank. Since the prerequisite of 1002 is to be removed for 3010, a COURSE CHANGE form is needed for 3010 and the catalog pages need be updated.
- COURSE CLOSURE/REMOVAL form for ATMS 4001-4002 – For #7, list ATMS 4003-4004 as replacement courses.
- COURSE ADDITION form and REQUEST FOR NEW COURSE NUMBER form for ATMS 1006 – suggest the use of “Intro Climate Change” as a better course abbreviation.
