

Index of Real GSP Growth: US, LA, TX







Annual % Change in Real Wage/Salary Disbursements




Construction Index: \$ of Real GSP/GDP




Annual % Change in Construction Employment




Annual % Change in Permits: Total Units




Manufacturing Index: \$ of Real GSP/GDP




Annual % Change in Manufacturing Employment



Retail Index: \$ of Real GSP/GDP




Annual % Change in Retail Employment



New Purchases of Motor Vehicle: US and Louisiana


Annual Percentage Change in New Vehicle Sales






Finance/Insu Index: \$ of Real GSP/GDP




Annual % Change in Finance/Insu Employment




Population Change by MSA: 2000-2010


% Change in Population: 2010-12

Net Migration as % of Population Change: 2010-12







% Change in Non-Farm Employment: 2007-12














% Change in Manufacturing Employment: 2009-2012

Index of Retail Sales Activity: Non-automotive*










Annual % Change in Inflation-Adjusted LA State Tax Revenue by type of Tax (2012 dollars)







Per Capita State Tax Collections




Per Capita Individual & Corporate Income Tax: 2010
