Dr. Arant made several requests pertaining to the resolution, including: that the resolution be submitted to the Provost's office for review and decision; the promotion pathway focuses on full-time/contract instructors, not adjunct instructors; a more detailed review process be explained; and starting individuals at the Lecturer level if they are highly qualified. The handbook draft currently has a policy on promotion from instructor to senior instructor to lecturer, with qualifications and extended contract terms listed and does not adequately address the review process as it focuses mainly on time served. Senator Anderson discussed how lacking this type of policy has impacted the Physics department and supports the effort to address this moving forward. Senator Starks asked if instructors are supposed to utilize the FAD, in which President McDaniel confirmed that they are; however, Dr. Arant has requested that the first year of employment for instructors should not necessarily rely on the generation of a portfolio. Senator Starks has volunteered to chair this committee and President McDaniel asked for Senators to volunteer to participate as well: Senators Anderson, Chamcheu, Golemon & Tresner volunteered to participate. Senator Tresner asked if the committee should address changing over to a tenure track and President McDaniel stated there is currently no charge to do so but felt that it should be included if feasibly possible. Senator Golemon discussed whether the University should be pursuing more economically disadvantaged and non-traditional students and having the University function differently to recruit & retain students (giving an example of adjustments being made to the tenure process) and President McDaniel briefly discussed the situation; Senator Colgrove provided input on the situation as well, mentioning streamlining bureaucracy within the institution. Senator Anderson mentioned that since the US population is shrinking that the University's reach be extended to other countries like Mexico & South America but also sub-Saharan Africa.

- Course release policy for Senate President: Dr. Arant has also categorized this as a very high priority since the policy has seemed to disappear. The policy should address course releases for the Senate President, fall course reductions for the past President and spring course reductions for the President-elect position. President McDaniel elicited feedback from Senators regarding the issue and the majority supported including reductions for all President positions in the drafted policy. The Senate officers/President will be tasked with creating this resolution and should complete this w/in the next week.
- Repeat & delete policy: President McDaniel gave a brief discussion describing instances where students are allowed to or prompted to repeat classes even if they have an A or a B; however, many Universities have policies that restrict when courses may be repeated. She suggested that the policy should provide strict guidelines as to when situations could utilize this type of action. Senator Veronee mentioned that consideration would need to be given to programs that use the same course number for sequential courses. The policy would probably need to include a list of affected courses or define terms. Senator Veronee is open to participating in a committee to develop this policy if it does not need to be completed in the immediate future. Senators Rowley & Yantis agreed to participate on the committee as well with a targeted completion for the end of the semester.
- Review sick leave policy: current policies need to be pulled and reviewed to look for discrepancies in application versus text and correct them as needed; Senate officers will handle this. President McDaniel mentioned Dr. Arant is looking into the time-sheet issue; maybe changing into a leave reporting system and going back to a monthly pay period rather than the current bi-weekly pay period.
