- Other people, only if they now live in your parents' household and your parent(s) will provide more than half of their support from July 1, 2019 through June 30, 2020 (grandparents, cousin, niece, nephew, etc.).

If you are an <u>independent</u> student (not required to provide parent information on FAFSA), you must include:

- Yourself
- Your spouse (if you are married)
- Your children, if you will provide more than half of their support from July 1, 2019 through June 30, 2020
- Other people, only if they now live in your household and you will provide more than half of their support from July 1, 2019 through June 30, 2020 (grandparents, cousin, niece, nephew, etc.). *

* You may be required to provide documentation for these additional individuals if listed in household size.
