Introduction & Purpose

- What is It?
 - LaCarte Purchasing Card (P-Card) is a VISA credit card issued by Bank of America ("BOA") that is used to make small-dollar purchases directly from vendors
 - The individual named on the card is responsible for making "business related" purchases that are in compliance with University and State policies
 - The P-Card carries a <u>corporate liability</u> and does not affect your personal credit
 - No fees. No interest.

- Purpose of the Program
 - Enables employees to make purchases with the convenience of a credit card
 - Streamlines purchasing, payment, and accounting process
 - Improves efficiency and effectiveness by reducing costs associated with processing of purchases and payments
 - Eases purchasing in emergency situations



P-Card Enrollment / Annual Review Form

To be completed for every new Cardholder and Approver **AND** Annually

- New Cardholder or Approver
- Change Cardholder or Approver Information (Profile, Approver, Department)
 - Change of personal information
 - Change of Department, Section, or Job Title
 - Change of Cardholder(s) or Approver
 - Change of Single Transaction Limit or any part of Spend Profile
- Delete/Close Cardholder
 - Bring the Purchasing Exit Form and intact P-Card to Procurement
 - Have the Purchasing Exit Form signed by Procurement in two places (if exiting the University)
- Annual Review of Cardholder
 - To be completed by every Cardholder and Approver ANNUALLY



Card Controls

- Monthly Billing Cycle
 - Begins on the 6th of the month, and ends on the 5th of the following month
- Single Transaction Limits
 - Dollar limit for individual transactions. If you exceed the dollar or transaction limits, your card will be declined at the point of sale
- Merchant Category Codes ("MCC")
 - Attempts to purchase from restricted and prohibited MCCs will cause the transaction to be declined at the POS
 - Travel is prohibited with a P-Card. Utilize an individual Travel Card (T-Card) or Department's CBA
 - Food merchants are prohibited from individual employee use unless an exception request is made to the State via the ULM P-Card Program Administrator to support the use of food merchants



Cardholders Responsibilities



P-Card Training

Cardholder's Responsibilities

- Directly responsible for appropriate card use
 - Sharing & lending cards is NOT allowed
- Keep the purchasing card in a safe and secure location
- Make allowable and appropriate purchases
 - Personal charges are STRICTLY PROHIBITTED
- Gather and assemble all supporting documentation (I.e., receipts, invoices, etc.)
- Obtain all necessary approvals (I.e., Approving Agent, Financial Manager, Grants, Foundation, etc.)
- Receive and inspect orders
- If sales tax is charged, it is the Cardholder's responsibility to request a credit to the Cardholder's account

- Receive individual monthly paper statement from Bank of America, or electronically
 - This is not a bill
- Cardholder should mark the Index and Account, as well as Activity (E.g. CV19) if applicable, on documents prior to submittal to the Purchasing Office, and it must be approved by your Department Head
- Surrender the card upon termination of employment, or upon request of the next-level supervisor, Department Head, or P-Card Administrator
 - Bring the card, along with the Purchasing Exit Form, and Employment Checkout Form (if exiting from ULM), to Purchasing for card receipt and destruction

P-Card Program

- How much can I spend?
 - P-Card purchases are limited to an individual's Single Transaction Limit ("STL"), not to exceed \$5,000 per transaction (including shipping and handling), as well as the monthly Credit Limit
- WARNING: Do not split a transaction
 - Purchasing items that exceed the STL and separating the payment into two or more transactions is NOT allowed
 - Artificially splitting a purchase is a violation of State law



Examples of Split Transactions

- A Cardholder has a single transaction limit (STL) of \$2,500 and wishes to purchase similar or complementing items with a total cost of \$3,000. The sale is divided into two (2) transactions of \$1,800 and \$1,200. This is considered a split transaction to avoid the STL and is not allowed.
- A Cardholder has a STL of \$2,500 and wishes to purchase an item with a total cost of \$3,500. The Cardholder makes arrangements with the vendor to pay \$2,500 one day, and the remaining balance the next day. This is considered a split transaction and is not allowed.
- A Department wishes to purchase an item or complementing items with a total cost of \$4,500. Two Cardholders with a STL of \$2,500 each within the same department use their cards to purchase the item(s) and two transactions occur (one on each card) for the purchase. This is considered a split transaction and is not allowed.



Receipts

- Original receipts must be submitted; Handwritten receipts are NOT acceptable
- Enter a Description on each Receipt when uploading to Works
- If you misplace a receipt, contact the vendor to a get a replacement receipt this is the fastest and easiest method
- If you cannot obtain a replacement receipt, complete a Missing Receipt Form, which is located on the P-Card section of the Purchasing page: www.ulm.edu/purchasingoffice/pcard.html. Multiple uses of the form in a fiscal year will result in suspension of card privileges.
- Receipts must have detailed purchase information, E.g., date of purchase, vendor name, description of item(s), quantity, unit price(s), total, and NO LOUISIANA TAXES
- Receipts on photo static paper (E.g., typical receipt from a retailer)
 - Should not contain writing or high-lighting this makes reading it difficult, even after a very short period of time
 - Must be taped to a full sheet of paper, trying not to place the tape over sections of the receipt text that contain the purchase details this makes reading it difficult, even after a very short period of time
 - Make a copy of the full sheet of paper
 - Attach the original taped to the paper, and the copy, to the statement
- For pre-authorized food purchases, a sign-in sheet or flyer must be uploaded and attached along with the receipt.



Returns & Credits

- The Cardholder is responsible for contacting a vendor immediately and arranging a return for replacement or credit
 - Do NOT accept cash in lieu of a credit
 - Request credit receipt or slip, upload to the transaction in Works, and attach to Statement
 - In Works, allocate the credit to the same Index and Account as the original charge
 - In Works, use Comments on the related debit and credit transactions to link them together
 - Please note that the credit may appear on a future statement so proper documentation is necessary to make sure the credit is issued and documented fully



Dispute Items

- Contact the P-Card Administrator if there are any charges on your statement that you do not recognize
- P-Card Administrator will direct you to complete the Statement of Disputed Item form (Located on the P-Card section of the Purchasing page)
- The credit for the disputed transaction may appear in future statement period. Be sure to watch for it, and link the credit and debit in the documentation that is uploaded to Works, and attached to the statement.



Lost or Stolen Cards

- Notify Bank of America IMMEDIATELY by calling
 - 888.449.2273 (available 7x24)
 - Zero personal liability
 - Lost or Stolen Cards will be shipped to the P-Card Administrator
 - Do NOT have BOA reissue a card directly to you. All cards must be received and distributed by the P-Card Administrator.
- Upon termination/transfer, the card must be cancelled and returned to the Purchasing Department – do not destroy the card yourself



Reporting of Fraud

• Any recognized or suspected misuse of the P-Card should be reported to the Program Administrator, and may be anonymously reported to the State Louisiana Inspector General's Fraud and Abuse Hotline at 866.801.2549



Other Important Information

- P-Card is to be used for official ULM business only
- Will NOT affect your personal credit
- Violators of policies and procedures will be subject to disciplinary action
- CAUTION VIOLATIONS:
 - Personal or unauthorized purchases
 - Split purchases
 - Alcohol

- Failure to comply with all P-Card policies are procedures may result in the following:
 - Payroll deduction
 - Account suspension/deactivation
 - Permanent loss of the card
 - Notification to administration, internal audit, Human Resources, and University police
 - Possible employment suspension or termination
- Your P-Card is NOT tied to Your Budget
 - It is the responsibility of the Cardholder to verify sufficient funding exists in the specified budget and expenditure code PRIOR to initiating the P-Card transaction

Ongoing Mandatory Requirements

Before Making a P-Card Purchase, the Cardholder Must:

- Verify sufficient funding exists in the specified budget and expenditure code
- Identify if the purchase is appropriate for a P-Card transaction
- Check list of restricted purchases
- Advise vendor that the P-Card is state sales tax exempt BEFORE the transaction begins
- Obtain detailed receipt and retain all documents



Annual Mandatory Requirements

- All participants sign the most current <u>P-Card Agreement Form</u> associated with their role in the program, and send it to Purchasing
- All participants complete the most current <u>P-Card Enrollment-Annual Review Form</u>, and send it to Purchasing
- All participants take the online <u>ULM training course</u>, and send their completion certificate to Purchasing
- All participants take the <u>online course in LEO</u> associated with their role in the program, and send their completion certificate to Purchasing
- Department Heads, along with all Approvers must review cardholders, cardholder limits, and ensure appropriate utilization of the card
- The Approvers, along with the Program Administrator, should also review the MCC codes to ensure they're working properly
- University to evaluate internal policy and procedures
- Compliance of all annual requirements, by all program participants, reviewed by ULM President and attestation sent to the Office of State Procurement

Works Workflow Process for Cardholders





P-Card Training

Cardholder Regular Activities in Works

All Cardholders must login to Works <u>at least weekly</u> to:

- Review transactions in Works
 - Match amount and vendor to receipt; Ensure no LA taxes were charged
- Enter comments and/or item description for each transaction
- Upload detailed, original receipts, sign-in sheets (when applicable), and additional approvals (when applicable)
- Add account codes to the GL segments
 - GL01 = Index
 - GL02 = Account
 - GL03 = Activity (E.g., CV19)
- Electronically sign-off on each transaction
 - Transaction is then sent to Approver in Works to review and sign-off
 - Credit balance is refreshed once signed-off by Approver



Cardholder Monthly Statement Activities

- Review all transactions and match to transactions in Works
 - Match amount and vendor on paper statement and receipt; Ensure no LA taxes were charged
- Cardholder and Approver both sign front page of statement
- Pull Billing Cycle Log from Works, print, sign; <u>Cardholder & Approver</u> both sign
- Attach all detailed, original receipts for charges <u>and</u> credits, sign-in sheets (when applicable), and additional approvals, E.g., Financial Manager, Principle Investigator, etc. (when applicable)
- Note the Index and Account codes on the statement and receipt for each transaction
- Tape photo static and/or undersized paper receipts to full sheet of paper, make a copy, and attach the original and the copy to the statement
- Return everything to Kelly Moravek, P-Card Program Administrator, by the <u>26th of each month</u>



Cardholder Transaction Sign-off in Works

- Log into Works: <u>https://payment2.works.com/works/home</u>
- Click on Sign Off Pending Transactions from the home page Action Items field
- Open the Transaction drop-down menu by hovering over the Transaction Number
- Click on Allocate / Edit to update the GL fields
- Click on Manage Receipts. Add the receipt by clicking Add, then New Receipt. Upload the receipt adding the date of the receipt and a description of the purchase, then click OK.
- After allocating, adding the receipt and description, sign-off either using the drop-down menu for each transaction, or by placing check marks next to all of the completed transactions and clicking Sign Off at the bottom of the page



Electronic Billing Cycle Log

- Log into Works: https://payment2.works.com/works/home
- Click on Reports from the home page
- Click Template Library in the dropdown
- Click on Billing Cycle Purchase Log
- Click on Modify/Run. It should default to the previous Billing Cycle in the Post Date Field. If not, select the Previous Cycle.
- Scroll to the bottom and click Submit Report (must be printed in PDF)
- The Completed Reports screen appears when the report it is ready
- Print the Electronic Log
- Turn in the Billing Cycle Log, signed by you and your Approver, with your Statement and receipts

Remember, if a transaction is not signed-off by both the Cardholder and Approver in Works, the amount of the transaction will not refresh in the Cardholder's monthly credit limit.

Approver Transaction Sign-off in Works

- Log into Works: https://payment2.works.com/works/home
- Click on Sign Off Pending Transactions from the home page Action Items field
- OpenTransaction drop-down menu by hovering over the transaction number
- Click on Allocate / Edit to update the GL fields, if applicable
- Hover over the transaction number and click on View Receipts, click PDF, click Open. <u>Review the receipt and supporting documentation and make sure it matches the</u> <u>transaction, and it is an approved purchase for business purposes</u>. Click Close.
- If everything is correct, Sign Off on the transaction by hovering over the transaction or checking the box next to the transaction, and clicking Sign Off
- If changes need to be made, click Flag Transaction and indicate what information needs to be corrected or added. Flagging a transaction will send it back to the cardholder's queue to be corrected and signed off again. He/she will NOT see an email notification of the flag, however, they will see flagged transactions when they sign into Works next time.



Important Dates: 5th, 12th, 26th

- 5th: Billing Cycle closes on the 5th of every month
- 6th: Statements available for download from Global Card Access (GCA)
- 12th: Statements should be received by the Cardholder by the 12th of the month - but not necessary if the statement is downloaded from GCA
- 26th: Hardcopy delivered and tasks completed in Works
 - All original, signed statements, with Purchase Log signed by Cardholder and Approver, receipts, and supporting documentation delivered to Kelly Moravek in Purchasing
 - All receipts and supporting documentation uploaded, allocations completed, and Cardholder and Approver approvals completed in Works
- Statements not received by the 26th of the month may result in card cancellation



P-Card Compliance

Per the State of Louisiana's Corporate Liability "LaCarte" Purchasing Card and CBA Policy:

"Cardholders, program administrators, program users, supervisors/approving officials, auditors or anyone associated with the card program who knowingly, or through willful neglect, fails to comply with any current purchasing policies, rules and regulations, mandates, Louisiana Statutes, Executive Orders, State Liability Travel Card and CBA Policy, internal agency policies and procedures and/or PPM49 as applicable may be subject to suspension or termination of account privileges or other disciplinary action, up to and including criminal prosecution to the fullest extent of the law. The Office of State Travel reserves the right to withdraw any authority or delegated approval due to non-compliance with applicable laws, rules, regulations, mandates, policies and procedures."

By selecting the **Organization** you want to get into, it directs you to the appropriate instance of Works. You'll see that your log in name is different for each, but your email address is the same, and you can have the same password on both systems if you choose. If a drop-down box isn't available next to Organization, by putting in your email address with the correct log in and password, you should get you into the correct system.

If you don't recall your password, click on 'Forgot Your Password'.
