Learfield representatives Greg Lynch and Drew Bellipanni –

- Learfield represents over 250 universities, which makes them the largest multi-media rights provider in the US. Learfield helps connect universities with their community and connect fans with their university brand. Learfield makes the partnerships and sponsorships happen for universities.
- Even though Greg and Drew are newcomers to the area, they have already made some good connections and are excited about the opportunities here. In addition to external relationships, Learfield works with campus departments and programs as potential sponsors. The company also offers internships to students.
- Another thing that Learfield does is protect the athletic logos and images from imitators by licensing the multimedia rights for apparel that is sold on and off campus.
- When a student athlete seeks to benefit from their NIL (name, image, likeness), Learfield protects the multimedia rights for the
 university.
- Learfield coordinates with ULM's Marketing & Communication department as needed.
- The athletic logo is used only with approval from Learfield through Greg, whether that's on paperwork or on items. The logo has to be protected to keep it from becoming too common. Other schools have the same proprietary control of their athletic logos.
- The academic logo is not licensed by Learfield, so it falls under different rules of use.
- Use of older logos is not permitted on newly produced items.
- Having the new logo that harkens back to the NLU logo has helped with community outreach. The wins this season have also helped.

New Business

- Treina Landrum gave a preview of Title IX mandated changes that have recently gone into effect. She will be send out an update so that we can stay in compliance. Treina will return for a fuller presentation during the November meeting. One change is that all employees are now mandatory reporters of sexual discrimination or misconduct. All reports need to go to Treina. Senators can email any questions to Treina in advance of the next meeting.
- The Staff Senate has been given a budget and can now pay for things we need. The Executive Board met to create a preliminary list of
 proposed categories for a budget. One of the categories is Projects, where a group can apply for funds to do something special. An ad hoc
 Finance Committee has been created with one member, Nicole Walker. Expenditure categories will be determined by the Executive
 Board and the Finance Committee. Senators are encouraged to be networking with their own departments to identify needs.
