³ In accordance with Act 472, the Chancellor’s report shall include the number and percentage of Responsible Employees and Confidential Advisors who have completed annual training.

⁴ Although this section is not required by Act 472, for data collection purposes BOR requests statistics regarding a responsible employees’ failure to comply with reporting requirements.

ULM Chancellor's Data Report Narrative October 12, 2021

The October 12, 2021 ULM Chancellor's Data Report reflects the number of Responsible Employees at ULM and the number of persons who completed training provided by the Board of Regents on August 18, 2021. This training was limited to a team of 8 persons from each Institution. The required training referenced by BOR Uniform Policy on Power-Based Violence/Sexual Misconduct has yet to be developed by the BOR, and has a deadline for development of January 1, 2022. Responsible Employees of the Institution have a requirement to complete the BOR training before the beginning of the 2022-2023 Academic Year.

As a result, 8/ (1%) of ULM's 1246 Responsible Employees have completed training provided by the BOR to date. However, 1117/ (90%) of ULM's 1246 Responsible Employees have completed the 2021 Preventing Sexual Harassment Training required for ULM Employees.

When the BOR's Annual Training becomes available, it will be provided to all ULM Responsible Employees.
